Re-establishment of Rights proceedings at the EPO is a remedy of last resort to rectify a missed deadline. Failure to successfully re-establish a patent right represents not only a loss of the patent right but often an opportunity for financial gain. Therefore, every patent practitioner needs to know how to most effectively navigate this remedy which has been shaped by more than 400 decisions of the Boards of Appeal of the EPO.
